# AN (ALMOST) COMPLETEY SUCCESSFUL INITIATIVE!



We're putting the finishing touches to our evaluation of the Home Energy MOT project our Energy group undertook, with partners Marches Energy Agency, over the autumn/winter 2022-23. And it's clear it has, in its own terms, been a clear success. Under the project:

- \* over 100 village households got free advice and low level installations/aides to promote their energy efficiency;
- \* the MOT visits, overwhelmingly undertaken by our own Graham Hirst, were warmly received;
- \* feedback was universally positive, with many citing how the visits improved household warmth and energy use;
- \* a significant proportion of households have since taken further steps of their own to ensure greater efficiency;
- \* aides issued and installed will save around three quarters of a tonne of carbon emissions annually, and;
- \* with further steps households are taking, we estimate in excess of one tonne of emissions will be being saved annually as a result of this project and associated changes households are making.

That all goes some way to achieving the estimated requirement that UK homes need to cut emissions by 3.4% annually if we are to get anywhere near achieving 'net zero' by 2050. Thank you, one and all!

The report will also identify the real need for altered approaches from public agencies to make 'cold homes' (predominantly stone-walled, with no meaningful cavity) fit for a net zero world. This means more flexible provision, and more help, with substantial deep retrofit options (e.g. external and internal wall insulation, air source heat pumps) to be available to households in more economical ways.

We'll soon send our report to local green activists and opinion leaders, suggesting the project's relevance elsewhere. And we'll make it available to you too. Why an 'almost' completely successful initiative? Because if we'd had more time and more resources, we could have done even more! But we're proud of what we achieved, in what may the UK's first project of its kind.

Even so, the UK government is refusing to ban the routine flaring and venting of methane from North Sea gas and oil drilling wells – despite the cost of this being outweighed by the value of the gas saved if retained for normal commercial use. ## BIODIVERSITY - Roger Cliffe updates us on our Biodiversity sub-group's growing range of activities

#### **Bats**

We've become familiar with the techniques of identification of bats using our ultrasound detector and have so far surveyed three areas around the village, with two more planned. We want to do more, in order to build up an accurate picture of bat populations around Hayfield, so if you have bats around your property or are simply curious to find out, we'd love to hear from you. Our detector is simple to use and comes with guidance, so if anyone would like to borrow it for a few days then please get in touch.



#### Moths

Similar to the bats, we want to know more about our local moth population and will be deploying our moth trap at various locations around the area over the next couple of months.

#### Wildflowers

We are monitoring the existing wildflowers on the bus station roundabout over summer (they have been giving a good display) and will enhance it with additional seeding in the autumn. We'd also like to establish further wildflower areas around the village and we are in discussions with another area which have done this very successfully using volunteers. Watch this space!

## **Hayfield Community Tree Nursery**

Our tree nursery is now set up at an initial three locations around the village, producing young trees for eventual planting out as part of a national effort to significantly increase tree cover in the UK. If you've any seedlings from seeds that you collected from us at Apple day last year, or you've grown your own from seed and are wondering what to do with them, you can now bring them to us to grow on in the nursery. There is a collection point outside the library entrance – just let us know when and where the seed came from (if you know) and where it's been growing. Thanks!



#### Volunteers

We're planning on carrying out several additional tasks in the coming months – removal of invasive species (Himalayan Balsam), pond restoration, collection of tree seeds and tree planting – for which we'll need volunteers. We'll put out more details separately.

#### SO, HOW, OVERALL, ARE WE DOING?

There's far too much lazy rhetoric in the UK about being 'world leaders'. Being realistic, a medium-sized economy in relative decline is only ever likely to be 'world-beating' in one or two large areas, and a few specialist fields.

But, regarding climate change, we have had claims in this field, notably via passage of the legally-binding Climate Change Act, and in our development of off shore wind resources. We've also closed our coal mines a lot faster than many. There's huge amounts left to do, but some good starts were made.

Now, in its latest, 400 plus page report, the government's independent The Climate Change Committee (CCC) has released a damning update warning that the UK has "lost" its global leadership position on climate change. The CCC found government efforts to scale up climate action as "worryingly slow", saying it was "markedly" less confident that the UK can reach its targets for cutting carbon emissions than it was a year ago.

**Targets**: Last year, the CCC said there were "credible" policies in place to make 40% of the emissions cuts needed over the next decade. Now, just 20% of those cuts are covered. Instead, it estimates that existing "credible" climate policies will see emissions flatline – and says only nine out of 50 key indicators are currently "on track". For those who are interested, see Carbon Brief's in-depth coverage of the report for more details.

**Expansion:** In recent weeks, the government has dismissed calls to end new North Sea oil-and-gas licences. Yet the CCC report states explicitly that "expansion of fossil fuel production is not in line with net-zero". And, surprise, surprise, seeing the government's inaction, large fossil fuel companies like Shell are committing to expanded fossil fuel extraction, and some reversal of previous commitments to develop renewables. They read the runes. Meanwhile, the CCC warned that "the UK could no longer expand any of its airports without closures or shrinking of capacity elsewhere" but there seems no government acceptance of this. And the CCC's Chair, a Conservative, has described the sanctioning of a new coal mine in Cumbria as 'madness'.

This is why we need to keep campaigning, as Cath Moss has suggested (page 2). And doing our bit, in our own ways. Our government is playing too slow and too loose with all our futures

That Group is now looking at how best to reinforce expectations around green practices from those seeking to use council land/premises for events.
